Business of the Year Award: This award shall be presented to a business that provides services to the community, a business that promotes the community and engages and promotes volunteer efforts.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce.**
2. Must be an upstanding citizen of the community.
3. Must be active in supporting charitable and civic events, and encourages its personnel to be active in the community.
4. Encourages its personnel to be active in the community.
5. The business continues to provide stable opportunities for employment.

New Chamber Member of the Year Award: This award shall be presented to a new chamber member that provides innovative products or services, demonstrates a willingness to contribute to the community through community service, participation in local events, activities and charities.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce**
2. Active participation in chamber activities.
3. Promoting membership and active involvement with the chamber.
4. Contributes talents to enhance chamber programs.
5. Over the past year, has made significant impact fulfilling the chambers goals and improving its operations.

Service Organization of the Year Award: This award shall be presented to an Evanston Non-Profit Organization. This organization should contribute to the community and clearly show their willingness to go above and beyond the normal duties of the organization.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce.**
2. Must be a non-profit organization.
3. Must have made exceptional achievements in building and supporting the community and enhancing the quality of life in Evanston. **** (Explanation of achievements required)**
4. Exhibits excellence in its use of resources.
5. Significant local presence (organization must be based in or have local chapter in Evanston).

Outstanding Business Person of the Year Award: This award shall be presented to a business person that demonstrate excellence, creativity and initiative in their business of profession and provides valuable services by devoting time and energy to improve the quality of life for everyone in the community.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce.**
2. Position of authority or responsibility.
3. Active interest in the betterment of the business community.
4. Recognized as a leader in the community.
5. Successful in their chosen profession.

Outstanding Customer Service Award (Individual): This award will be presented to a Chamber member in good standing. Nomination criteria should include some of the following: A person who exemplifies high standards, giving priority attention to every guest and/or customer.

Criteria:

1. **Must be a member (or employed by a member) of the Evanston Chamber of Commerce.**
2. Viewed by his/her peers as a true customer service professional.
3. Goes above and beyond customer expectations in every circumstance.
4. Genuine and sincere, this person does what they say they will do, does it correctly and completely the first time, and follows through with promises to customers and teammates.
5. Contributes to the overall success of the team and customer experience by placing service above self.

Outstanding Customer Service Award (Business): This award will be presented to a Chamber member in good standing. Nomination criteria should include some of the following: A business that exemplifies high standards, giving priority attention to every guest and/or customer.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce.**
2. Viewed by their industry *and* community as a genuine customer service-oriented establishment.
3. Goes above and beyond customer expectations in every circumstance.
4. Works to quickly resolve any issues and empowers employees to correct deficiencies.
5. Contributes to the overall success of the team and customer experience by promoting positivity in employment practices and fairness in business transactions.

Lifetime Business Achievement Award: This award shall be presented to a business that has made an extraordinary contribution, touching the lives of the people of the Evanston area with a selfless spirit of service and giving more to our community over the years.

Criteria:

1. **Must be a member of the Evanston Chamber of Commerce.**
2. Must have an outstanding record of accomplishment in their chosen field
3. The significance of the achievements should be reflected in their community reputation and the recognition they have received from their peers ** (*Explanation of achievements required*)
4. Nominees must have enjoyed a full career having demonstrated business leadership for a significant number of years.

Citizen of the Year Award: This award will be presented by the City of Evanston in recognition of outstanding contributions to the Evanston community in the past year. This person’s exemplary efforts should demonstrate creativity, vision, leadership and citizenship. Service should enhance the welfare of the overall population and not be focused in a singular event or activity.

Criteria:

1. Evanston resident.
2. Active in community vision, events, and/or projects.
3. Promoter of the community and its efforts.
4. A person who has a passion to make Evanston a better place to live.
5. Someone with integrity and accountability.

Volunteer of the Year Award: This award will be presented by the City of Evanston in recognition of a volunteer that has gone above and beyond the call of duty.

Criteria:

1. Evanston resident
2. Exhibits a passion in a certain area of the community need.
3. Passionate to make Evanston a better place to live.
4. Active in volunteering in either one project or organization or many projects or organizations.
5. Someone with integrity and accountability.
